

# Golden Prairie Press Affiliate Agreement

## Affiliate Terms and Conditions

This Agreement contains the Terms & Conditions that apply to each individual person or entity that joins the Golden Prairie Press Affiliate Program. As used in this Agreement, “we”, “us”, or “our” means Golden Prairie Press or any of our affiliate companies, as the case may be, and “you” means the applicant. In case of breach of this agreement, Golden Prairie Press reserves the right to terminate the Affiliate enrollment and freeze affiliate earnings and refuse withdrawal at any time at sole discretion of the company.

By enrolling in the Golden Prairie Press Affiliate Program you agree to the following terms.

Every contractually capable individual or entity is allowed to enroll in the Golden Prairie Press Affiliate Program that accepts and adheres to this Agreement.

### 1. Order Processing

All orders placed through your personalized affiliate link will be processed by Golden Prairie Press or one of its contracted companies. Golden Prairie Press reserves the right to reject or cancel any order prior to processing. In case of fraudulent transactions (for example credit card chargebacks) or returns, we reserve the right to reverse already credited Affiliate commissions. You will have access to Affiliate reports summarizing your sales activity in the affiliate login area.

### 2. Payment of Commissions

Commissions are paid on the 15th day following the end of each quarter. If the 15th day of the month falls on a weekend or holiday, payment will be made the first business day following. Commissions under \$25 will be held until the amount reaches \$25.

Affiliate commission will only be paid on the total product value (without shipping charges).

You may not purchase products through your own affiliate links for resale or commercial use of any kind. Such purchases may result (upon our sole discretion) in the withholding of referral fees and/or the termination of this Agreement.

### 3. Taxes

Taxes. Company shall not be responsible for any taxes owed by Affiliate arising out of Affiliate’s relationship with Company as set forth in this Agreement. Company shall not withhold any taxes from the Commissions paid to Affiliate.

### 4. Compliance with Laws

By participating in the Golden Prairie Press Affiliate Program, you agree as a participant to willingly comply with all laws, ordinances, rules, regulations, orders, licenses, permits, judgments, decisions, or other requirements of any governmental authority that has jurisdiction over you, whether those laws, etc. are now in effect or later come into effect during the time you are a participant of the program.

It is also prohibited to send bulk e-mails (spam) that contain links to Golden Prairie Press without prior consent of the recipient.

#### 5. Term of the Agreement

The term of this Agreement will commence upon our acceptance of your Affiliate Program application and will end when terminated by either party. Either party of this Agreement is allowed to terminate it at any time, with or without cause, by giving the other party a 30 day written notice of termination. Sales commissions will no longer be paid upon termination of the Agreement.

#### 6. Intellectual Property

Company retains all right, ownership, and interest in the Promotional Materials, and in any copyright, trademark, or other intellectual property in the Promotional Materials. Nothing in this Agreement shall be construed to grant Affiliate any rights, ownership or interest in the Promotional Materials, or in the underlying intellectual property, other than the rights to use the Promotional Materials granted under the License.

#### 7. Modification

We may modify this agreement as well as our Rates Options guidelines at any time and in our sole discretion, by posting an updated agreement at the Golden Prairie Press website. You must terminate your affiliate status with us if any modification has been found unacceptable for you.

#### 8. Limitation of Liability

We will not be liable for indirect, special, or consequential damages (or any loss of revenue, profits, or data) arising in connection with this Agreement or the Affiliate Program, even if we have been advised of the possibility of such damages. Further, our aggregate liability arising with respect to this Agreement and the Affiliate Program will not exceed the total referral commissions paid or payable to you under this Agreement.

#### 9. Advertisement Restrictions

Golden Prairie Press prohibits the participation of websites that are determined unsuitable for the Golden Prairie Press Affiliate Program due to, but not limited to, legal and ethical reasons.

Possible reasons for this might be websites:

- with pornographic content
- that glorify violence, contain youth endangering material or defame or discriminate a person or a group of people because of their religion, their race, their handicap or other reasons
- that contain racist or sexist content
- that infringe intellectual property of others
- that contain variations of the Golden Prairie Press logo
- that violate national or international law
- that contains anti-biblical or unbiblical content
